## **GENERAL TERMS AND CONDITIONS OF RENTAL**

It is agreed and decided that the client accepts the booking conditions and rates.

He therefore agrees to comply with the following conditions:

- All reservations are nominative and cannot be transferred under any circumstances.

The reservation will only be considered valid after the contract has been signed, the deposit paid, and the booking confirmation sent by the campsite has been received. This confirmation must be presented upon your arrival .

- In the absence of a message from the camper indicating that they had to postpone their arrival date, the mobile home becomes available 24 hours after the scheduled arrival date indicated on the booking contract. Telephone messages must be confirmed in writing.
- The full amount of the stay is payable on the day of arrival. No discount will be given for late arrival or early departure compared to the reservation dates.  
Our rates include: rental of the mobile home, crockery, water, gas and electricity consumption, bedding (blankets, pillows, mattress protectors, excluding sheets), garden furniture and parasol. Tourist tax is extra.
- In case of cancellation, the deposit will not be refunded to the tenant except under certain conditions (death in the family, serious illness requiring home care, hospitalization) and after receiving the supporting documents.

**The mobile home is rented by the week, from Saturday at 4:00 PM until the following Saturday at 11:00 AM.**

The rental period can be adjusted upon request in April, May, June, and September, with a minimum stay of two nights. In July and August, the mobile home must be rented for one week. Any delay, even if justified, will not result in any special discount on the rates.

A security deposit of €250 will be paid by the client upon arrival. This will be refunded after an inventory check on the day of departure, provided that the inventory matches the initial condition of the property. If the inventory does not match the condition of the property, a deduction will be made for the cost of repairs and the value of any missing or damaged equipment.

A sum of €75 will be deducted from the security deposit in the event that

The rented accommodation was not cleaned on the day of departure.

- It is the client's responsibility to obtain insurance. The campsite declines all responsibility in case of theft, fire, inclement weather, and in case of incidents falling under the client's civil liability.
- Animals are not allowed in the mobile home, thank you for your understanding.
- All campers are required to comply with the provisions of the campsite's internal regulations

- In the event of a dispute, jurisdiction is delegated to the court of Mende. In the event of a dispute, and after contacting the establishment's customer service department, any campsite customer has the option of contacting a consumer mediator within a maximum period of one year from the date of the written complaint by registered letter with acknowledgment of receipt to the operator.
